Rental Overlay District Established in Whitehills

Last autumn, the East Lansing City Council approved petitions, signed by a two-thirds majority of homeowners, to establish a residential rental overlay district in Whitehills pursuant to city ordinance 1035C. Your WNAEL led this important effort, organizing teams to visit homeowners and solicit support. The overlay district established for the Whitehills neighborhood provides the highest level of protection: new rental licenses are prohibited entirely. Existing rental properties are "grandfathered" and may continue to issue leases. Many neighborhood property owners spent precious free time on the petition drive, and sincere thanks are owed to each and every one. A tip of the hat is due to Mia Danigelis, Jim and Cheryl Little, Thomas Jones, Dick and Barb Fenech, Dave Zygmontowicz, and Scott and Sara Murray for extraordinary contributions to this project.

News from our Neighborhood/City Liaison

All of our entrances continue to be maintained by LandMark Landscaping Company. LandMark will weed, fertilize and mow all entrances this Summer. After Memorial Day, annuals will be planted at all the entrances by neighborhood volunteers (clear your weekend calendar, dust off those rakes and spades, and grab your gardening gloves!). This will help us stay within our landscaping budget and the savings will allow us to plant additional foliage at the Foxcroft entrance and proceed with Phase III of our long-term landscaping plan. All annuals will be purchased from the Christians Greenhouse Fundraiser for Donley School.

We would like to thank Mr. and Mrs. Doug Roberts who, for a second year in a row, have made a generous landscaping donation for improvements to the Northgate entrance.

Shedding Light on the Shade Tree Situation

With the spread of the Emerald Ash Borer (EAB) in the Lansing area over the past few years, you are probably noticing less shady streets around the community and the Whitehills neighborhood. In an effort to help reduce the impacts of EAB, we encourage you to consider planting a tree in your yard this spring or fall. The same applies to all those other appendages of modern life that seem to materialize out of nowhere as summer approaches. Boats, RVs, trailers, wave runners, commercial vehicles---all must be maintained in completely enclosed structures or stored somewhere other than your property.

STOP!!! Have You Chatted With the Pride/Covenants Committee Lately?

With springtime well underway, the nesting instinct is in full force, and that includes humans! Some of you will start dreaming about, and planning, improvements to your property, whether a swimming pool or pool house, an addition to your house or garage, a new fence or perhaps a deck or patio. In addition to meeting city set-back requirements and obtaining city permits, remember that each of the above proposed projects also must pass muster under the terms of the covenants (deed restrictions) that apply to your particular property. These include additional set-back requirements, size limitations, material specifications, etc. As soon as you contemplate an improvement project and have plans drawn accordingly, submit them for review to the WNA Pride Committee, c/o Thomas Jones, 1625 Hitching Post Road, 332-1683; thomasjones@tajones.com. The sooner your plans are submitted, the sooner your project will be up and on its way, assuming it meets all the factors contained in your covenants.
